Course Description

This course explores the major components and principles of the macroeconomy. Students will learn basic models and rules as well as a brief introduction to subfields within the broader macroeconomic subject. After completing the course, a student will possess a grasp on the fundamentals which shape the macroeconomy as well as the basic questions which direct those engaged in research.

Assignments: Following nearly every class there will be a short (one or two questions) assignment which you must complete. These are completion grades. In other words, so long as you submit the assignment, you will receive full credit. We will review the answers in the subsequent class.

Midterm and Final Exams: There will be two exams in this class. They will be take-home exams due the following class (see class schedule). There will be a short-answer and multiple-choice section. The short answer questions will ask you to draw upon the readings and lectures, recalling important points. The short-answer portion will ask you to take our economic tools and apply them in a more original manner.

Participation: Attendance in class is certainly mandatory but participating in class also augments your grade. In particular, there will be several points to discuss readings, news stories, and other items. Active participation during these times is important to your grade.
